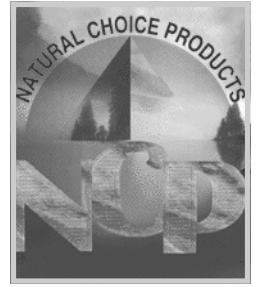

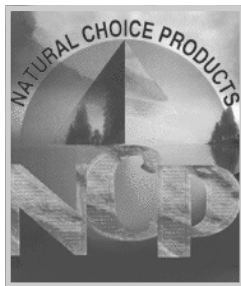

PAYMENT AUTHORIZATION: I authorize NCP to withdraw payment for my Autoship order from my credit card or bank account identified on this Agreement. If I have elected to participate in the electronic checking program, I hereby authorize NCP to electronically withdraw payment from my checking account for orders I placed directly and for Autoship orders as authorized in the Customer Agreement. NCP is authorized to withdraw payment equal only to the amount of the products and shipping and handling of products that I order, or the Autoship that I have selected. I agree to pay a \$15.00 service fee in the event a check or charge is returned for any reason. I have the right to have the amount of any erroneous withdrawal deposited into my account as soon as possible and upon proper notification to NCP. I shall not hold NCP harmless for all special or consequential damages, whether direct or indirect, resulting from any wrongful debit to my account.

CHANGES: To change Autoship order selections, method of payments, or the authorized amount, a new Agreement form must be submitted to NCP. If more than one Agreement has been submitted, the most recent Agreement will supersede all previous Agreements. NCP reserves the right to substitute products and/or prices without notice.

Any changes to my Autoship package and/or any orders I may place in lieu of my monthly Autoship order MUST BE MADE 24 HOURS IN ADVANCE of my Autoship date, or my Autoship package will be sent and debited from my account.

Please note:

If 24 hour notice is not given in order to stop the monthly Autoship there will be a 10% restocking fee. If the order has already shipped there will be a 10% restocking fee and it is the responsibility of the customer to pay the shipping for the return.

NCP Return Policy

We at NCP sell only the highest quality products, however, if for any reason a customer should be dissatisfied with any item purchased directly from NCP, that item may be returned WITHIN 30 DAYS for a refund (less 10% restocking fee).

Procedure

The following procedure applies to all returns or exchanges:

- All products being returned must have a Return Authorization Number which can be obtained by calling the sales department at 800-626-5143. This number must be written on each carton returned.
- Proper shipping carton(s) and packing materials are to be used. The risk of loss in shipping for returned product is the responsibility of the customer. If the items are not received it is also the responsibility of the customer to track the package.
